

BY-LAW NUMBER 40-2023
OF
THE CORPORATION OF THE CITY OF BRANTFORD

Being a By-law to amend By-law 30-2023, being a By-law to Fix Fees and Charges to be collected by The Corporation of the City of Brantford for 2023.

WHEREAS By-law 30-2023 as amended, is a By-law passed under the authority of Part XII of the Municipal Act, 2001 to fix fees and charges;

AND WHEREAS City Council has determined that the fees and charges set forth in By-law 30-2023 should be amended as set forth in this By-law;

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRANTFORD HEREBY ENACTS AS FOLLOWS:

1. In this By-law, references to By-law 30-2023 shall mean By-law 30-2023 as amended from time to time.
2. By-law 30-2023 is hereby amended by amending Schedule "1" in the following fashion:
 - a. Reference Number 1284 is amended by deleting the following words "Non-refundable";
 - b. Adding a new fee Reference Number 1308 as "Civil Marriage Solemnization Fees - Cleaning Fee per incident in the amount of \$200.00 for use of confetti, rice, bubbles, candles, incense, music and similar items at Civil marriages conducted on City property;" and
 - c. Reference Number 324 is amended by deleting "2 hour minimum" and inserting "1 hour minimum"
3. This By-law comes into effect immediately.
