

BY-LAW NUMBER 105-2020
OF
THE CORPORATION OF THE CITY OF BRANTFORD

Being a By-law to amend By-law 210-2019, being a By-law to Fix Fees and Charges to be collected by The Corporation of the City of Brantford for 2020.


WHEREAS By-law 210-2019 as amended, is a By-law passed under the authority of Part XII of the Municipal Act, 2001 to fix fees and charges;

AND WHEREAS City Council has determined that the fees and charges set forth in By-law 210-2019 should be amended as set forth in this By-law;

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRANTFORD HEREBY ENACTS AS FOLLOWS:

1. In this By-law, references to By-law 210-2019 shall mean By-law 210-2019 as amended from time to time.
2. By-law 210-2019 is hereby amended by replacing the Sports Field Fees identified on Schedule 12 with the revised Sports Field Fees attached to this By-law therefor as "Appendix A".
3. This By-law comes into effect immediately.
